MULTIPURPOSE OFFICE BUILDING IN MARIBOR

The office building stands on a land plot measuring 915 m2. It is divided into two floors. In total, it measures 445 m2.

The ground floor measures 232.81 m2 in total. There is a cafe (56.09 m2), a warehouse (11.46 m2), a garage (22m2), six technical communication rooms (27.48 m2), a service station (39.28 m2), a shop (42 m2), and an office.

On the first floor, which measures 211.88 m2, there are four larger office spaces and several technical communication rooms.

There are 20 private parking spaces and direct access from the main road.

The facility was built in 2006 and is regularly maintained.

Type of construction: wooden, prefabricated (type JELOVICA). Windows: wooden, with aluminium blinds. Connections: to water, electricity and gas network, telephone connection, CATV and internet. Heating: Natural gas central heating.


